#### **WELCOME TO NEW BOARD MEMBERS**

Evenson referred the board to page 2 of the report and recited the Opinion paragraph, which indicates that the audit is materially accurate and without errors — a clean audit opinion. Evenson then referred to page 14 and discussed the 2018 fund balance. Jacobson and Titera requested a 10 year comparison of Fund Balances. Evenson agreed to provide this during the 2019 audit and may work with Sprynczynatyk to produce the figures earlier. #### **DIRECTOR'S REPORT**

Lynch discussed the 2019 Legislative Session and the two bills for RLBSS Funding and Legacy Funding. Regarding Legacy Funding, the Regional Public Library Systems are asking for a continuing allocation of \$2.5 million annually from the Arts and Cultural Heritage Fund. Regarding RLBSS, the Regional Public Library Systems are asking for an increase of \$4 million, plus a formula change. The Regional Library Systems are also willing to accept less than \$4 million as long as all system are held harmless.

We are thrilled that local Senator Mark Johnson is the Chief Author of the RLBSS bill and that other local legislators are willing to support his bill.

Lynch addressed two questions that were asked at a previous meeting regarding the RLBSS bills:

Q: Why do we always attach the bill to the Education Omnibus Bill?

A: If the legislature were to allow one interest group/item/client to access the floor for with a standalone bill, others would want the same. The volume of actions that would have to be taken at the full House or Senate level would increase markedly as a result.

Q: Why haven't we asked for indexing for funding?

A: One legislature should not remove decision making authority from the next legislature. As a result, they focus on their two year biennial cycles – and leave the future to the future.

Lynch discussed the 2018 Donor Report that was sent out in February.

Lynch shared a message sent to the LARL Board from Arlen Syverson.
