COVID-19 Service Update

All LARL locations (with the exception of Cormorant) are currently offering Express Library Service, which includes the following:

- Customers must wear a mask (following Executive Order 20-81). LARL is providing masks to those who do
 not have one. If the customer refuses to wear a mask, alternative services are offered, such as curb-side
 pickup.
- Customers are encouraged to use hand sanitizer when entering the building and are asked to limit the touching of library items.
- Customers are encouraged to limit their browsing time to 20 minutes.
- Customer computer time is limited to 45 minutes. A librarian may extend the session for an additional 45 minutes if it is needed and if no one else is waiting.
- Programs and events are only occurring online and outside.

In-person traffic is still down in all locations, while online use of eBooks, eAudiobooks and other downloadable resources and online programming have increased.

Because in-person traffic is still down, six employees remain furloughed and three positions remain unfilled.

Career Force and Coursera

State Library Services is currently facilitating a statewide partnership between MN Career Force and Public Libraries to aid in employment recovery. LARL will be marketing a resource called Coursera to the general public, which is made available through MN Employment and Economic Development. Coursera is an online learning platform that hosts over 3,800 courses and learning modules from over 200 universities and businesses from around the world. All Minnesotans can access this resource at no cost by registering by September 30, 2020. Everyone who participates will have access to complete coursework through March 31, 2021. Visit www.CareerForceMN.com/Coursera to gain access.

CARES Act Grant

The LARL CARES Act Grant for technology upgrades and digital inclusion has been submitted for a total of \$134,000.

Mahnomen Otto Bremer Trust Grant

New shelving, tables and chairs have been ordered for the Mahnomen Library. Next steps include repairing the ceiling, painting the interior, painting the exterior trim, and replacing the front door.

MN Public Libraries

MN Public Libraries continue to show their strength by working together to meet the needs of Minnesotans during this difficult time. The MN library community has proven their value by adapting and responding to community needs and will continue to aid in recovery, focusing on economic recovery, workforce development, student success and digital inclusion. Over the next few months/years, Minnesotans are going to need public libraries more than ever before.
